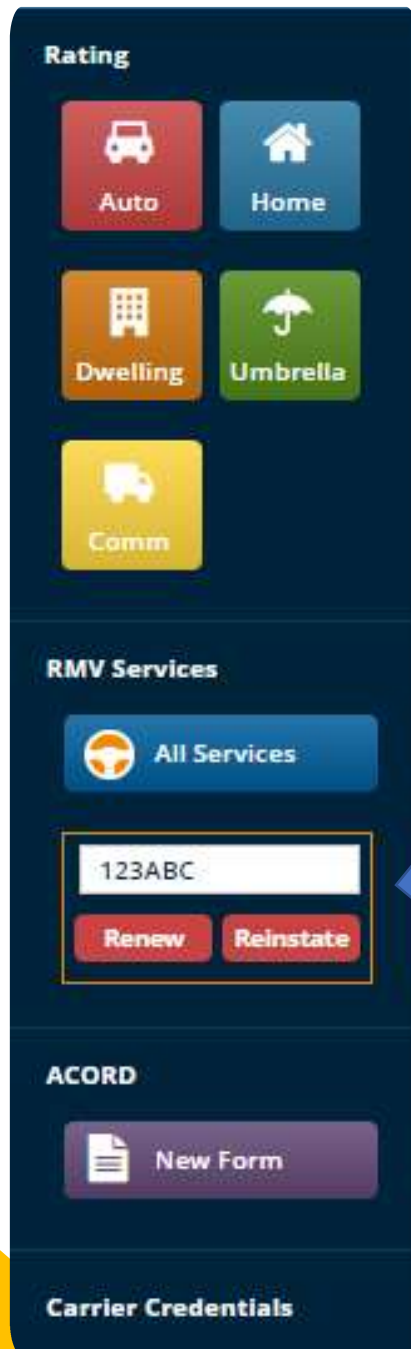

There are 2 ways to process a registration reinstatement in SinglePoint. A Rapid reinstatement and long form reinstatement. 1st we will show the RAPID version.

From the SinglePoint dashboard on the left under RMV Services enter the plate # you wish to reinstate. Then click reinstate.
